HIGHLIGHTS

UK rental company Vp plc has acquired TechRentals NZ in New Zealand for NZ\$ 2.592 million (€1.7 million). TechRentals rents specialist test and measurement equipment and offers equipment calibration services, and has been operating for more than 30 years. It has a single location in Auckland, New Zealand.

India's access sales and rental company Mtandt Group has reported an estimated 60% increase in revenue for its 2015/2016 financial year. The company said it had plans to invest US\$ 100 million over the next two years on a new manufacturing facility for scaffolding and other equipment and to increase its rental fleet. Mtandt distributes XCMG's hydraulic fire trucks up to 102m reach height and is Indian dealer for Ruthmann's Steiger truck mounts.

Loxam and TVH pursue Lavendon

It is the second time that TVH has

approached Lavendon regarding an

acquisition, with Lavendon rejecting a TVH offer in 2010.

Loxam and TVH are separately pursuing the acquisition of UK-based powered access renter Lavendon Group.

Belgian parts and rental business TVH made a 205 p per share bid for Lavendon on 22 November, but that bid was rejected by Lavendon, who said it had consulted with some of the shareholders approached by TVH and that "the level of support anticipated

was not forthcoming." Less than a week later Loxam announced it was discussing a possible cash offer with Lavendon, adding that there was no certainty that any offer will be made. Loxam urged Lavendon shareholders not to support the TVH offer.

In its initial bid, TVH said it would not increase its offer price unless a third party made an offer for Lavendon. TVH, which already has major aerial platform rental operations in the Netherlands (Gunco) and Germany (Mateco), offered 205 pence per share, valuing Lavendon at £348 million, a 47.5% premium on the price at close of trading the day before the offer. The share price had risen to 218 p by 30 November. In rejecting TVH's initial offer,
